

VENDOR LIABILITY AGREEMENT

THIS VENDOR LIABILITY AGREEMENT (“this Agreement”) is made by and between Living Arrangements for the Developmentally Disabled (LADD, a 501c3), Special Olympics Hamilton County, The City of Cincinnati, Cincinnati Recreation Commission, Cincinnati Park Board, Great Parks of Hamilton County, and the undersigned contractor or subcontractor (“Contractor”), under the following circumstances:

A. **Venue** Otto Armleder Memorial Park & Recreation Complex is a 238-acre site managed in partnership with the Great Parks of Hamilton County and the Cincinnati Recreation Commission. It features hiking trails and a bike path, a playground, shelters, recreational fields/ meadows, a large dog park and provides access to the Little Miami Scenic River.

B. **Owner/ Operator/ Manager** Otto Armleder Memorial Park & Recreation Complex is a joint venture between the City of Cincinnati, Cincinnati Park Board, Cincinnati Recreation Commission and Great Parks of Hamilton County in Ohio. Great Parks maintains the dog park and the Cincinnati Recreation Commission manages the park’s soccer fields and pavilion.

C. **Event Producer/ Primary Contractor** Living Arrangements for the Developmentally Disabled (LADD Inc., a 501c3) is an organization that provides a variety of community-based services for adults with disabilities across Hamilton County, Ohio. **Event Partner** Special Olympics Hamilton County provides year-round sports, training and competition in a variety of sports for children and adults with intellectual disabilities.

C. In consideration of Owner/ Operator/ Manager/ Event Producer/ Primary Contractor approving the vendor agreement/ contract and permitting Contractor or its subcontractor (s) to deliver its goods or provide its services for the **September 30, 2017 LADD Fitfest** event at **Otto Armleder Memorial Park & Recreation Complex**, Owner/ Operator/ Manager/ Event Producer/ Primary Contractor has required that Contractor or sub-contractor both indemnify it from liability and assure it that sufficient liability insurance is in existence.

NOW, THEREFORE, Event Producer/ Primary Contractor agrees as follows:

1. Contractor or its subcontractor (s) hereby covenants and agrees to indemnify and hold Owner/ Operator/ Manager/ Event Producer/ Event Partner Primary Contractor harmless from any damage, claim or liability, including reasonable attorney fees and costs of litigation, caused by the negligent acts or omissions of the Contractor or its subcontractor (s), employees, agents or anyone directly or indirectly employed by it or anyone whose acts they may be liable for.
2. Contractor covenants that it and each of its subcontractors entering upon and commencing work within Otto Armleder Memorial Park & Recreation Complex will be fully covered by a comprehensive liability insurance policy and that all of their employees will be covered under the Ohio Worker’s Compensation Program paid for by the Contractor or its subcontractors and Contractor assures Owner that no non-covered persons will be allowed to work within the premises. Contractor further agrees to indemnify and hold Owner/ Operator/ Manager/ Event Producer/ Event Partner harmless from any damage, claim or liability, including reasonable attorney fees and costs of litigation, arising out of its failure to maintain either such liability insurance or worker’s compensation coverage.
